
Managing business data in compliance comes at a price

For the Romanian domestic market, our services provide deep integration with the Romanian National Agency for Fiscal Administration (ANAF) to simplify the mandatory e-Factura, e-Transport and Tax Declarations (SAF-T) reporting. A dedicated Intrastat service is also available for economic operators that have to declare cross-border movements of goods between EU Member States (INTRASTAT) to the Romanian National Institute of Statistics.
